### **Frequently Asked Questions**

### Why is Canada Council conducting this survey?

The Council is gathering information that will help measure, understand and demonstrate the outcomes of the Digital Strategy Fund's Special Initiative for core recipients, and its potential benefits on grant recipients. Council is inviting Special Initiative grant recipients to fill out a short survey about the benefits of the grant on their organization's digital transformation. #### How will the survey results be used?
