

## Venice Fellowship

2025 Venice Architecture Biennale

### Guidelines

The Canada Council for the Arts Venice Fellowship offers a unique opportunity to spend one month in Venice (Italy) engaging with Canada's official entry to the 19th International Architecture Exhibition – La Biennale di Venezia, from May 10 to November 23, 2025. This initiative is open to students and graduates of Canadian schools of architecture and/or early career practitioners in the field of architecture and/or art.

The <u>Venice Biennale</u> has been one of the most important cultural institutions in the world since 1895. The International Architecture Exhibition consists of a central exhibition with over 100 international participants, 60 national pavilions and collateral events throughout the city. It is a prestigious exhibition and international platform that engages critical conversations about contemporary architecture that attracts 300,000 visitors annually, among them architects, artists, designers, critics, politicians, students and cultural leaders from around the world.

The fellowship supports independent research as well as practical experience in overseeing the daily operations of the Canada Pavilion in the Giardini di Castello. Some of the activities include:

- managing the pavilion four days a week during public opening hours;
- guarding the exhibition;
- greeting visitors;
- providing guided tours;
- tracking attendance; and
- ensuring that the pavilion is clean and that the exhibition content is in good condition.

Knowledge of Canadian architecture and art as well as the ability to work independently and in a team setting are essential. Fluency in English is required. Knowledge of other languages, especially French and Italian, is beneficial.

The Canada Council will award 14 fellowships (two per month) prioritizing applicants who self-identify as First Nations, Inuit or Métis, Black, racialized, Deaf or having a disability, from official language minority communities, youth, 2SLGBTQ+, gender-diverse communities, women, and those at intersections of these identities. The Canada Council will also ensure that the fellowship cohort reflects the regional diversity of Canada. A shared apartment in Venice will be provided in addition to the grant to help support travel and living costs.

Deadline: October 15, 2024

Grant amount: \$5,000

**Application limit:** You can submit 1 application per deadline.

Notification of results: Approximately 3 months after the deadline

### Applicants – Who can apply?

 Students or graduates from Canadian schools of architecture and/or early career practitioners in the field of architecture and/or art

 Canadian citizens and/or permanent residents of Canada, as defined by Immigration, Refugees and Citizenship Canada

You may be eligible for <u>Application Assistance</u> to pay someone to help you with the application process if you are experiencing difficulty and self-identify as:

- an artist who is Deaf, is hard of hearing, has a disability or is living with a mental illness; or
- a First Nations, Inuit or Métis artist facing language, geographic and/or cultural barriers.

You cannot apply for activities that are on the general list of ineligible activities.

#### Assessment - How are decisions made?

Your application will be internally assessed on the following weighted criteria:

Impact (60%)

• The potential of the fellowship to contribute to your professional development

Feasibility (40%)

Your capacity and experience to undertake the fellowship

The applicants with the highest scoring applications will be contacted by the Canada Council for a virtual interview. Following the virtual interviews, the Canada Council will select the fellows.

#### **Grant payment and final reports**

If your application is successful, the first step in receiving your grant payment is to complete the Grant Acceptance Form. Click <u>here</u> for more information on the responsibilities of grant recipients.

A final report will be due 1 month after your fellowship.
